WHAT TO DO AFTER A FALL

Liss & Marion has recovered millions of dollars for clients who have suffered injuries due to falls. Injured victims are entitled to compensation from businesses and property owners for uneven pavements, icy conditions, slippery wet floors, and other hazards on walking surfaces or stairs. According to the National Safety Counsel, approximately nine million people in the United States require emergency room care each year for treatment of injuries suffered in a slip, trip or other fall down accident.

If you or someone you know suffers injury from a fall, consider the following:

- If possible, take lots of photographs of the hazard that caused the fall. Show the area from various angles and distances. This is important to preserve evidence if the property owner cleans or repairs the hazard.
- 2. Get the name and contact information of any witness.
- 3. Promptly report the incident to the business and/or property owner.
- Do <u>not</u> sign any statements or documents. Do <u>not</u> give a recorded telephone or other statement to anyone.
- 5. <u>Contact Liss & Marion as soon as possible</u> so that your attorneys can begin an investigation and properly document your claim.
